Flax worked closely with REED during an Agile development process building a flexible indexer for the complex database structures; hundreds of millions of database rows were to be indexed along with CVs held external to the database in different formats and languages.

HP buys Autonomy

The news wires have been positively buzzing since the announcement that Hewlett Packard will be buying Autonomy for £7.1bn. Many commentators have put a positive spin on this, pointing to Autonomy's meteoric rise from a small office in Cambridge to the behemoth it is today. It is undoubtedly good news for Autonomy's shareholders. Dave Kellogg correctly identifies Autonomy as a "finance company dressed in (meaning-based) technology company clothing" with a "happy ending".

However the reaction isn't all positive – the FT implies this deal is at the "lunatic end of the valuation spectrum". Law Technology News says "Autonomy's ediscovery revenue stream is high-end but unsustainable".

HP will have to work hard to integrate Autonomy into both its corporate culture and software frameworks — a problem currently faced by Microsoft since its acquisition of FAST. With the rise of open source options and realisation that huge license fees are unsustainable, Autonomy may not be the last company looking for a safe haven in the years to come.
